ARTICLES OF INCORPORATION

The undersigned incorporator makes and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation is: FLORIDA DONGYU INVESTMENT, INC.

ARTICLE II

Principal Office/Mailing Address

ARTICLE III

Term of Existence

This corporation shall commence as of the date of the filing of these Articles with the Secretary of State and shall have perpetual existence.

ARTICLE IV

Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE V

Capital Structure

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100,000 shares of common stock, having a par value of \$.01 per share.

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors or the shareholders.


ARTICLE X

The incorporators executed these Articles of Incorporation this 31st Day of January, 2001.




