THE UNDERSIGNED, who has the capacity to contract, hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit pursuant to Chapter 607 and 621 Florida Statutes (FS).

ARTICLE 1. NAME AND ADDRESS

The name of this corporation shall be STARTCHURCH.COM, INC. The physical address of this corporation is 870 N. Gratton Rd., Clewiston, FL 33440. The mailing address is Rt. 1 Box 31-A, Clewiston, FL 33440.

ARTICLE 2. PURPOSE

The specific purpose for which the corporation is initially organized is to provide high quality products to religious and nonprofit organizations which assist in the establishment and growth of such entities, and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose.

ARTICLE 3. SHARES

Any Director may also serve the corporation in any other capacity and receive compensation therefrom in any form.
