

ARTICLES OF INCORPORATION

OF

The undersigned hereby forms a corporation for profit under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be Pasco Towing & Transport, Inc. The address of the principal office of this corporation shall be 5633 River Gulf Drive, Port Richey, Florida 34668 and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
