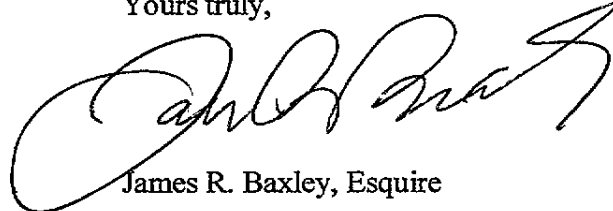

ARTICLE I-NAME

The name of this corporation is Parker Investment Properties, Inc.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

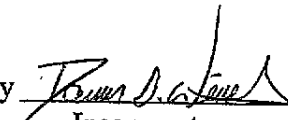
ARTICLE X-AMENDMENT

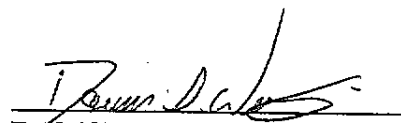

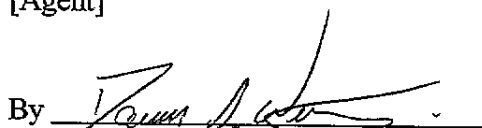
