The undersigned Incorporator, being a person competent to contract, subscribes to these Articles of Incorporation to form a Corporation for profit under the laws of the state of Florida.

ARTICLE I - Name

The name of the corporation is **Salber Salon, Inc.**

ARTICLE II - Principal Office

The principal office, and mailing address of the corporation is **8011 Citron Court, Orlando, FL 32819.**

ARTICLE III - Capital Stock

The maximum number of shares of stock that the corporation is authorized to issue is **1000 shares** of common stock having par value of **Ten (\$0.10) Cents** per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE IV - Initial Registered Office and Agent

The purpose for which the corporation has been formed is: To engage in and transact any and all lawful business permitted under the laws of the State of Florida and of the United States.

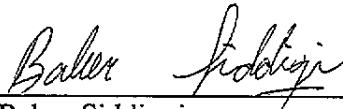
ARTICLE VIII - Term of Existence

ARTICLE IX - Amendment to Articles

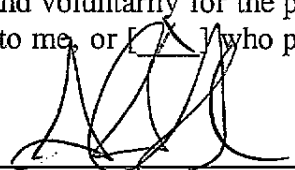
These Articles of incorporation may be amended in such manner as provided in the By-Laws of the corporation.
