The undersigned hereby organizes a corporation for profit under the Provisions of the Florida General Corporation Act, and pursuant to the following Articles of Incorporation

ARTICLE 1

Name

Indemnification


The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


