# ARTICLES OF INCORPORATION OF BLUEFISH BAY PUBLISHING, INC.

The undersigned incorporator files these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

# <u>ARTICLE I</u>

# **NAME**

The name of the corporation is BLUEFISH BAY PUBLISHING, INC.

# ARTICLE II

# **DURATION OF THE CORPORATION**

This corporation shall exist perpetually unless dissolved according to law.

# ARTICLE III

# **CORPORATE PURPOSE**

The purpose of this corporation is for the book publishing business and such other business activities, including the ownership of real and personal property, as are necessary and incidental to the operation of the business, or any other lawful business.

#### ARTICLE IV

### <u>AUTHORIZED STOCK</u>

The authorized stock of this corporation shall consist of 100 common shares at \$1.00 par value per share.

# **ARTICLE VIII**

### **INDEMNIFICATION**
