SECOND AMENDMENT TO ARTICLES OF INCORPORATION
OF

R. DAVID HEEKIN, M.D., P.A.
(hereafter to be known as Southeast Orthopedic Specialists, Inc.)

The Articles of Incorporation of R. David Heekin, M.D., P.A., a Florida corporation (the "**Corporation**"), filed with the Florida Secretary of State on February 7, 2001, as amended by Articles of Amendment filed on January 22, 2015 (as amended, the "**Articles of Incorporation**"), are hereby further amended pursuant to Fla. Stat. § 607.1006 as set forth in this Second Amendment to Articles of Incorporation (this "**Amendment**"):

1. **Name and Document Number.** The name of the Corporation immediately prior to the filing of this Amendment is R. David Heekin, M.D., P.A., and its document number on file with the Florida Secretary of State is P01000014210.

2. **Approval of Amendment.** This Amendment was unanimously adopted and recommended to the Corporation's shareholders by the Corporation's Board of Directors, and unanimously approved by the shareholders, on March 26, 2015. The number of votes cast for the Amendment by the shareholders was sufficient for approval.

3. **Amendment to Article I.** Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"The name of the corporation ("Corporation") is Southeast Orthopedic Specialists, Inc., and the street address of the principal office and the mailing address of the Corporation are 6500 Bowden Road, Suite 103, Jacksonville, Florida 32216."

4. **Amendment to Article III.** Article III of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"This Corporation is organized under Chapter 607, Florida Statutes, as amended from time to time, for any lawful purpose, including, but not limited to, the provision of orthopedic services and other medical services."

5. **Adoption: Effective Date of Amendment.** This Amendment was adopted on March 26, 2015, but shall become effective on May 31, 2015.

6. **Effect of Amendment.** The Articles of Incorporation shall remain in full force and effect except as expressly modified by this Amendment.


