



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE 1. Corporate Name

The name of this corporation is NESBITT SAFETY CONSULTANTS, INC.

ARTICLE II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any or all lawful business permitted under the laws of the State of Florida.

ARTICLE III. Capital Stock
