ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is TEADWATANASUK, INC. The mailing address is 15513 S.W. 147th Court, Miami, Fl 33187.

ARTICLE II - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida and the United States.

ARTICLE III - DURATION

ARTICLE IV - CAPITAL STOCK
