The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE I

The name of the corporation shall be **Zelda's**, **Inc.**, hereinafter referred to as the "Corporation."

#### ARTICLE II

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### **ARTICLE III**
