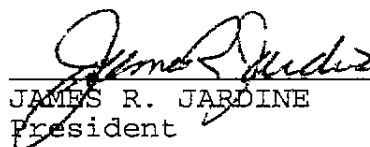
The undersigned, pursuant to Florida Statutes Chapter 607
