ARTICLE 3. The principal place of business and mailing address of this corporation shall be 127 Crown Point Circle, Longwood, Florida 32779.


ARTICLE 4. The corporation is authorized to have outstanding at any one time 1000 shares of stock, at a par value of \$0.01 per share.
