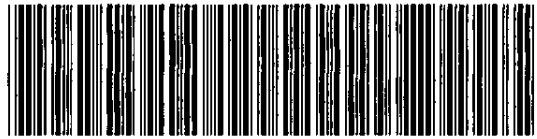

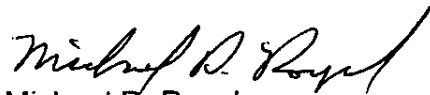

Effective as of the filing date of these Amended Articles of Incorporation, the name of the corporation is 4675 Investments, Inc.

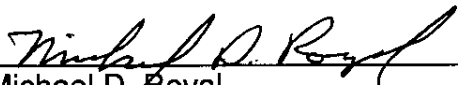
ARTICLE 6 – PURPOSE OF CORPORATION (added)

The amendment was adopted by the board of directors without shareholder action and shareholder action was not required.

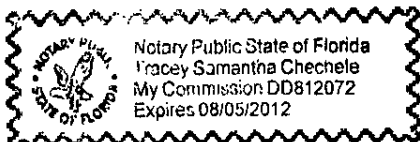
