**ARTICLES OF INCORPORATION  
OF  
WHITEFEATHER SERVICES, INC.**

**ARTICLE I. NAME**

The name of this corporation shall be:  
WHITEFEATHER SERVICES, INC.

The principal place of business shall be 8340 44<sup>th</sup> Court South, Boynton Beach, Florida 33436.

**ARTICLE II. NATURE OF BUSINESS**
