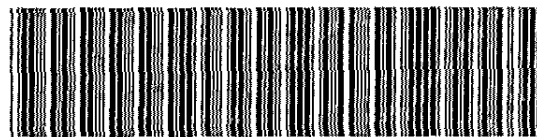

The dissolution was authorized by a meeting of the shareholders and directors held March 01, 2005.

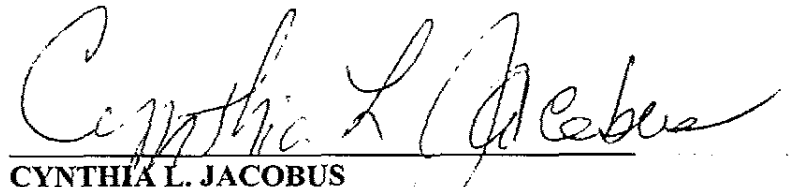
ARTICLE III

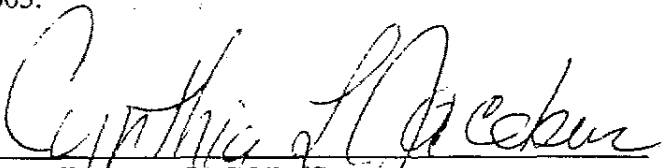
