

ARTICLES OF INCORPORATION  
OF

ARTICLE I. CORPORATE NAME

The name of the corporation is : Bliss Feed & Supply, Inc.

The principal place of business of this Corporation shall be:

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock (Having a par value of \$1.00 per share).
