NAME: The name of this corporation is: J.A.P. CLEANING SERVICES, INC.

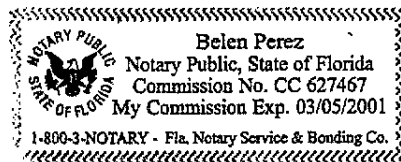
