

ARTICLE IV: INITIAL DIRECTOR


The initial Director of the corporation shall be Brian Clews, whose address is 835 N.W. 82nd Avenue, Plantation, FL 33324.

The Incorporator of this corporation is Brian Clews, whose address is 835 N.W. 82nd Avenue, Plantation, FL 33324.


