The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is NEW CLEANERS ENTERPRISES INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 11474 STINGER WAY, JACKSONVILLE, FLORIDA 32256, (904) 745-0052.

ARTICLE VI


BOARD OF DIRECTORS: The initial board of directors shall consist of one (1) member. The name and address of this person who is to serve as director is as follows:

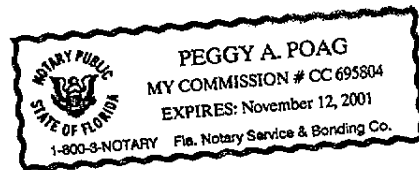
