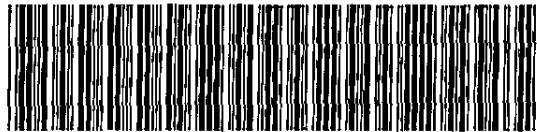

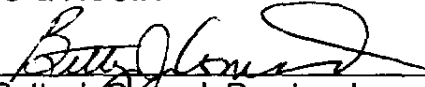

ARTICLES OF AMENDMENT FOR NAME CHANGE

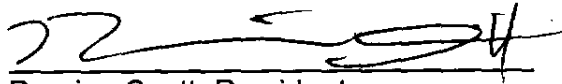

The name of the corporation shall be SARIS TECHNOLOGIES, INC.

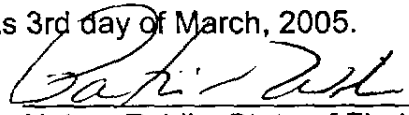
2. The foregoing amendment was adopted by the Stockholder and Director of the corporation on the 3rd day of March, 2005.
