ARTICLES OF AMENDMENT**

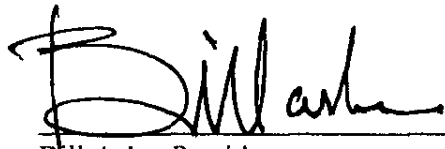
