ARTICLES OF INCORPORATION

The undersigned incorporator, hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the Florida Business Corporation Act and in accordance with the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be Consumer's Marketing Group Inc. The effective date of incorporation shall be February 10, 2001.

ARTICLE II

EFFECTIVE DATE
2-10-01

The general nature of the business or businesses to be conducted by this corporation, together with and in addition to those powers conferred by the laws of the State of Florida upon corporations organized under and by virtue of the laws of Florida shall be as follows:

- (a) To render services and/or buy, sell, deal in, lease, hold personal property, but not limited to etc
- (b) To operate various business ventures within the State of Florida.
- (c) To borrow money and contract debts necessary for the transaction of its corporate rights.
- (d) To apply and qualify to carry on the general nature of business or businesses as authorized by this corporate charter and/or any amendments hereto in any state of the United States of America.
- (e) To do all and anything necessary and proper for the accomplishment of the objectives enumerated in its Articles of Incorporation or amendments thereof or necessary of incidental to the protection or benefit of the corporation and, in addition to the specific powers enumerated herein, to have any and all rights, powers and privileges which are granted to corporations incorporated

under the laws of the State of Florida and in that connection to carry on any lawful business necessary or incidental to the attainment of the objectives of the corporation, whether such business is similar in nature to the objectives set forth in the Articles of Incorporation or any amendment thereof.

ARTICLE III

- (1) There shall be only one class of capital stock. All common shares shall have equal voting rights. There are no special conditions or limitations.
- (2) The corporation is authorized to issue 1,000 shares at \$.10 per share.
- (3) The par value per share is \$.10

ARTICLE IV

This corporation shall have perpetual existence.


