ARTICLES OF INCORPORATION

OF

Jon S. Newman, P.H.D., P.A.



The undersigned subscriber to these articles of incorporation, being duly licensed to practice Psychology under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I. NAME

The name of the professional service corporation is Jon S. Newman, P.H.D., P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 4048 Evans Avenue, Suite 304, Ft. Myers, Florida 33901.

ARTICLE III. PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of Psychology. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE IV. TERM OF EXISTENCE

The professional service corporation shall have perpetual existence starting on the date these articles of incorporation are filed by the Florida Department of State.

ARTICLE V. CAPITAL STOCK

The capital stock of the professional service corporation shall be 100 shares of common stock having a par value of \$10.00 per share.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice Psychology in the state of Florida.

ARTICLE VI. REGISTERED OFFICE AND AGENT

ARTICLE VII. BOARD OF DIRECTORS

ARTICLE VIII. INCORPORATOR

ARTICLE IX. RESTRAINT ON ALIENATION OF SHARES

The shareholders of the professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. If any shareholder becomes legally disqualified to practice Psychology in the state of Florida, is elected to a public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

ARTICLE X. AMENDMENT

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.
