Dear Sir or Madam:

We have enclosed the 2002 Uniform Business Report [UBR] for Pennington/Sealey Construction, Inc., [hereinafter sometimes taxpayer or corporation] and the taxpayer's check in the amount of \$150.00. For the reasons we have detailed below, we are requesting the \$400.00 late filing fee be abated.

The taxpayer was incorporated in 2001. The taxpayer operates a small construction business in Lakeland, Florida. In late 2001 and early 2002 the construction business increased dramatically. The corporate officer/shareholders, during this period, were working seven days a week in an effort to meet the construction deadlines. The taxpayer also experienced a turnover of office personnel during early 2002. Mr. Sealey, the corporation's president, was unaware the UBR had been received by the corporation until he received the second UBR recently. While going through his files, Mr. Sealey discovered a former office worker had been misfiled the 2002 UBR when the form was received. Mr. Sealey has always conscientiously filed his state and federal returns and he believed the corporation was in compliance with all State of Florida and Federal filing requirements.

Subsections 213.21(2)(a) and (3), F.S., authorizes the State of Florida to compromise a liability for tax, interest, or penalty. In regard to the penalty, the taxpayer must show that the noncompliance was due to reasonable cause and not willful negligence. The taxpayer shall be required to set forth in a written statement the facts and circumstances which demonstrate the existence of reasonable cause.

The standard used in the determination of whether the noncompliance was due to reasonable cause is whether the taxpayer exercised ordinary care and prudence and was nevertheless unable to comply.


Death, illness, or incapacity of the taxpayer is a basis for reasonable cause when such circumstances directly prevented compliance or adversely affected the taxpayer's ability to comply. Reliance upon another person to comply with the filing requirements, or obtain information, or to properly prepare returns or reports, is a basis for reasonable cause, depending upon the circumstances. **Noncompliance due to nonperformance of a ministerial type function, inadvertent misplacements of returns, reports, or information, or the failure of the taxpayer's agent to properly prepare or file returns or reports are each a basis for reasonable cause** when the taxpayer establishes the adequate procedures or steps for complying existed; or that extenuating or unusual circumstances prevented compliance.

Due to the increase in the taxpayer's workload and the demands in the construction industry, the corporate office/shareholders relied upon its office personnel to keep them informed about state and federal filing obligations. The former office personnel apparently misfiled the form and the filing deadline was missed. Based upon the application of the law to these facts we believe the taxpayer has reasonable cause for the late filing of the UBR. We are therefore requesting the late filing fee be waived. We have enclosed the UBR and a check in the amount of \$150.00 for the annual fee.
