

ARTICLES OF INCORPORATION
OF

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of this corporation is BOUCHLAS TRUSTEE & ASSOCIATES, INC.

ARTICLE II

ARTICLE VIII


