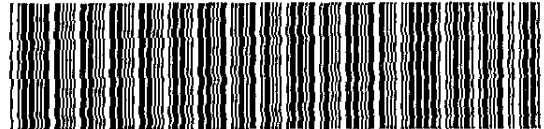


**ARTICLES OF DISSOLUTION FOR
