ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ME AND MY DOG TRAINING SCHOOL, INC.

ARTICLE II

The existence of the Corporation shall begin on February 7, 2001 and shall be perpetual.

ARTICLE III

Purposes: The purposes for which this corporation is organized are as follows: To provide service to the community which will teach people how to train their own family pets and to provide a daycare setting for puppies and dogs.

ARTICLE IV

The street address of the principal office of the Corporation is 434 Waterford Circle East, Tarpon Springs, FL 34689.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

The street address of the Corporation's initial registered agent is 434 Waterford Circle East, Tarpon Springs, FL 34689.

The initial registered agent for the Corporation at that address is Joel Zuckerman.

ARTICLE VII

The initial board of directors shall consist of 2 members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The names and addresses of the persons who will serve on the initial board of directors are:
