In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Forrico Trading, Inc. The mailing and street address of the principal office of the Corporation is 1012 Eckles Drive, Tampa, Florida 33612.

ARTICLE II

The Corporation shall have perpetual existence, commencing upon the date of filing of these Articles of Incorporation with the Florida Secretary of State.

ARTICLE III

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ten thousand (10,000), par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 1304 DeSoto Avenue, Suite 203, Tampa, Florida 33606. The initial registered agent for the Corporation at that address is Gail Martin Abercrombie.

ARTICLE VI

The initial board of directors shall consist of one (1) member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The name and address of the person who will serve on the initial board of directors is:



The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


