The undersigned incorporator, for the purpose of forming a corporation Articles of Incorporation.

ARTICLE I

The name of the corporation shall be RUN-A-SHIFT, INC.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The general purpose for which the corporation is organized is:

- 1. To engage in the business of providing temporary certified shift management personnel to corporations.
- 2. To transact and other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage into any other trade or business which can, in the opinion or the shareholders of the Corporation, be advantageously carried on in connection with and auxiliary to the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing

ARTICLE IV

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 at one dollar par. Such shares shall be of single class and shall have a par value of ONE DOLLAR (1.00) per share.
