

# ARTICLES OF INCORPORATION OF RICKY L. BELL PAVING, INC.

The undersigned subscriber to these Articles of Incorporation, Ricky L. Bell, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

# ARTICLE I

# CORPORATE NAME

The name of this Corporation is RICKY L. BELL PAVING, INC. The principal office and mailing address of the corporation is 2662 Riverview Drive, Naples, Florida 3412.

#### ARTICLE II

#### **DURATION**

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

# ARTICLE III

# **PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE IV

#### CAPITAL STOCK

The Corporation is authorized to issue 1000 shares of \$1.00 par value stock, which shall be designated "common shares." The stock of the Corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and all regulations issued thereunder. Such actions as are necessary will be taken by the officers of this Corporation in order to qualify under Section 1244. This Corporation is being capitalized and its stock is being issued to comply with the aforementioned section of the Internal Revenue Code.

# ARTICLE V

#### INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 2662 Riverview Drive, Naples, Florida 34112, and the name of the initial registered agent of the Corporation at that address is Ricky L. Bell. The Director(s) of this Corporation may from time to time change the registered office or registered agent, or both, by appropriate notice to the Secretary of State.

# ARTICLE VI

#### **DIRECTORS**

The Corporation shall have not less than one Director, as provided by the By-Laws.

Director(s) shall hold office for the term provided in the By-Laws or until their successor(s) have been duly elected and qualified.
