

The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporations Act, does hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of the Corporation is Gate-Scapes Company, Inc.

ARTICLE II
TERM OF EXISTENCE

Existence of the Corporation shall be perpetual. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III
NATURE OF BUSINESS




