## **Articles of Incorporation**

**Of**

### **Advanced Cleaning & Maintenance, Inc**

The undersigned, for the purposes of forming a corporation under the Florida Corporation

Does hereby adopt the following Articles of Incorporation:

#### **ARTICLE ONE**

NAME: The name of the corporation is Advanced Cleaning & Maintenance, Inc

#### **ARTICLE TWO**

DURATION: The duration of the corporation is perpetual.

#### **ARTICLE THREE**

PURPOSE: The purpose for which the corporation is organized are the following:

- A. To engage in and transact any lawful business of which corporations may incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purpose of the corporation or Necessary or desirable in order to accomplish them.

#### **ARTICLE FOUR**

CAPITAL STOCK: The aggregate number of shares which the corporation authorized to issue is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

INITIAL BOARD OF DIRECTORS: The number of Directors constituting the initial Board of Directors is two. The number of Directors may be increased or decreased from time to time on accordance with the By-Laws, but shall never be less than one.

COMMENCEMENT OF CORPORATE EXISTENCE: In accordance with Section 607.167, Florida Statutes, the date when the corporate existence shall commence as of the date of filing these Articles of Incorporation.

## ARTICLE NINE

PREEMPTIVE RIGHTS: Each shareholder of the corporation shall have the right to Purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the price for which it is offered to others, that shareholder's pro rate portion of the following:

A. Any stock of any class that the corporation may issue or sell, whether or not Exchangeable for any stock of the corporation of any class or classes, and whether or not of unissued shares authorized by the Article of Incorporation as originally filed or by any amendment thereof or out of shares of stock of the corporation acquired by it after the issuance thereof, and whether issued for cash or other consideration; or

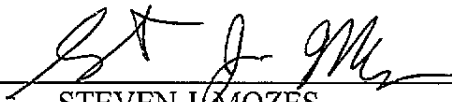
B. Any obligation that the corporation may issue or sell which is convertible or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.

This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days after receipt of written notice from the corporation stating the price, terms and conditions of the issue of shares and inviting the shareholder to exercise this preemptive right. This right may also be waived by a written waiver signed by the shareholder.

ARTICLE TEN


AMENDMENT: The corporation reserves the right to amend or repeal any provisions  
Contained in these Articles of Incorporation or any other amendment to them, and any  
Right conferred upon the shareholders is subject to their reservation.

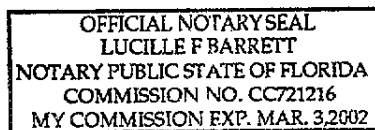

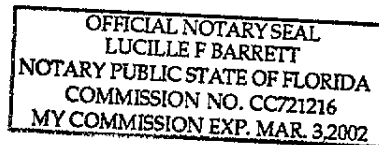
