Where do I begin my story? So many things have gone wrong in the last two years, it seems as if nothing really matter anymore. It is just the will to survive that has taken over. Please excuse the format of my letter.

### Let's begin:

- 1) I have been a self employed jewelry repair contractor for the last few years. Service Merchandise Corporation, my former employer, prior to contracting with them, went bankrupt last year, and my income simply went to zero overnight. I had no other vendor accounts.
- 2) My wife was diagnosed with advanced stage cataracts in both eyes, and we still can't afford necessary. She also has unpaid bills owing to her doctor, which has now been sent to collection. She is diabetic and can't see him because of the money owed. She has now missed five visits that are necessary to monitor her various ailments. We are too young for medicare, and can't afford private insurance.
- 3) Adding to our personal/financial woes, my father was in hospital in Toronto for a short stay, and in the process, he fell off his bed and broke his neck. He died in two days. The hospital forgot to put up the bed rails. We had to go to Toronto and could not afford the airfare. We drove for the trip and did arrive on time to see him alive.
