### ARTICLES OF INCORPORATION OF AGNES CHAU, P.A.

The undersigned incorporator(s), being duly licensed to practice law under the laws of the State of Florida, hereby adopt(s) these Articles of Incorporation to form Agnes Chau, P.A.
