

#### ARTICLES OF DISSOLUTION

## PLAN OF COMPLETE LIQUIDATION OF: MANTENER KEY BISCAYNE, INC.

This <u>Plan of Complete Liquidation</u> ("Plan") is effective as of April <u>ZQ</u>, 2006 and is attached as Exhibit A to that certain <u>Written Consent of Sole Shareholder</u>, dated April \_\_\_\_, 2006 ("Written Consent") and made a part thereof.

- 1. MANTENER KEY BISCAYNE, INC., a Florida corporation ("Corporation"), shall be completely liquidated in accordance with the provisions of Section 607.1403 of the Florida Statutes, as amended ("Statutes"), and this Plan.
- 2. MANTENER LIMITED, an entity formed under the laws of the Commonwealth of The Bahamas ("Sole Sharcholder") hereby acknowledges that it is the owner of 100% of the issued and outstanding shares of stock of the Corporation, and possesses 100% of the total voting power of the Corporation.

#### 3. Pursuant to this Plan:

- a. The Corporation's sole director has taken all reasonable steps to pay all corporate debt, taxes and other obligations or set up a reserve for the payment of the Corporation's debts, taxes and other obligations.
- b. The Corporation's sole director shall make distributions of all the cash, property, rights to property, and rights belonging to the Corporation to the Sole Shareholder in complete cancellation and redemption of all the stock of the Corporation.
- 4. All of the liquidating distributions described in paragraph 3(b) shall be completed within three (3) years after the close of the taxable year in which the first liquidating distribution is paid to the Sole Shareholder. The first liquidating distribution shall be made during calendar year 2006.
  - The Corporation's only remaining asset is cash in bank account.
- 6. As soon as the first liquidating distribution has been paid, the Corporation will cease to be a going concern and its activities will be limited to winding up its affairs, paying its debts, distributing its remaining assets to the Sole Shareholder, and dissolving.

- 7. The Corporation will retain no assets following its final liquidating distribution.
- 8. The Corporation shall dissolve in accordance with Florida law as soon as practicable after the final liquidating distribution.
