ARTICLES OF INCORPORATION

OF

DONAHAY'S AIR CONDITIONING & REFRIGERATION, INC.

ARTICLE I-Name

The name of this corporation is Donahay's Air Conditioning & Refrigeration, Inc.

ARTICLE II- Principal Office

The address of the principal office is 11921 US 27 South, Sebring, Florida 33876.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock


