**ARTICLES OF INCORPORATION**  
**OF**  
**STANLEY G. GORSICA, P.A.,**  
**ATTORNEY AND COUNSELOR AT LAW**

The undersigned incorporator, who is duly licensed to practice law in the State of Florida, for the purpose of forming a professional service corporation under Chapters 607 and 621 of Florida Statutes, adopts the following articles of incorporation for the corporation:

**ARTICLE I**

**Name**

The name of the corporation is STANLEY G. GORSICA, P.A., ATTORNEY AND COUNSELOR AT LAW.

**ARTICLE II**

**Principal Office**

The street address of the corporation's principal office is 1833 Halstead Boulevard, Suite 1410, Tallahassee, Florida 32308, and the mailing address of the corporation is the same.

**ARTICLE III**

**Duration**

The duration of the corporation shall be perpetual.

## ARTICLE IV

### Corporate Existence

The corporate existence will commence on the filing of these articles of incorporation by the Department of State.

## ARTICLE V

### Purpose

This corporation is organized for the following purpose:

To engage in the practice of law and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this corporation. The corporation may own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

## ARTICLE VI

### Professional Services

The professional services of this corporation shall be rendered only through its officers, employees, and agents who are duly licensed or otherwise legally authorized to practice law in the State of Florida.

## ARTICLE VII

### Capital Stock

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is One Hundred (100) shares. These shares shall be of a single class of common stock, and shall have a par value of One and No/100 Dollars (\$1.00) per share. The shareholders shall have preemptive rights to acquire proportional amounts of the corporation's unissued shares upon the decision of the board of directors to issue them.

## ARTICLE VIII

### Directors

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one (1), and the name and address of the initial director is:

The number of directors set forth in these articles of incorporation and constituting the initial board of directors shall be the authorized number of directors until that number is changed by a bylaw of the corporation.


