The undersigned, desiring to form a corporation for profit pursuant to the laws of the State of Florida, does hereby certify as follows:

l. Name

The name of the Corporation is, **NBT CREATIVE INVESTMENTS, INC.**, hereinafter referred to as the "Corporation."

II. Purposes & Nature

The general nature of the business to be transacted by the corporation and the purpose for which it is formed are to be as follows:

and all powers, rights, and privileges which a corporation may now or hereafter be organized, authorized, or empowered to do or exercise under Chapter 607 of the Florida Statutes, or under any act amendatory thereto, or substituted therefore.

(c) The foregoing paragraphs shall be construed as enumerating the purposes, objects, and powers of this corporation and no recitation, expression or declaration of specific powers or purposes herein enumerated shall be deemed to be exclusive, but it is hereby expressed and declared that all other lawful powers not inconsistent herewith are hereby included.

III. Principal Office

The principal office of the Corporation is 4805 West Laurel Street, Suite 250, Tampa, Florida 33607. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida.
