To Whom It May Concern:

I was recently made aware that my corporation had been administratively dissolved due to nonpayment of the Annual Fee for 2002.

Not knowing exactly what this was about, I asked my accountant. He explained to me that I should have paid the annual renewal fee (of \$150.00) on or before May 1, 2002 to keep my corporation active in your system. He explained that I should have received an original Uniform Business Report from your office in January or February of 2002, and described what the form looked like.

I do not recall receiving such a form from your office. I believe that the problem is two-fold. First, there has not been any activity for my corporation since the time that I started it up. This is because I took another job with a local contractor, and (up to this point) have not used my corporation for its intended purpose. Secondly, I moved my home/office during the early part of 2002 and do not believe that your UBR form was properly forwarded to my new address. *I have changed my address as shown on the attached UBR.*


Finally, since I was not familiar with Florida's corporation reporting requirements, I did not know to expect the UBR form during the first part of 2002.

In consideration of the facts presented herein, I respectfully request that you waive the reinstatement fees.

I have completed and attached a UBR/reinstatement application, with a check in the amount of \$300.00 to cover the annual fees for 2002 and 2003.
