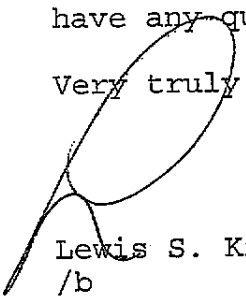

ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida Law.

1. NAME. The name of this corporation is THE FAMILY CENTER FOR COUNSELING AND LAW, P.A.
2. TERM. The corporation shall exist perpetually.
3. PURPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes. The Practice of Law.
4. CAPITAL STOCK. This corporation is authorized to issue ONE HUNDRED (100 ) shares of common stock with each having a par value of ONE CENT (\$.01 ). The board of directors may dispose of the authorized but unissued stock from time to time, but every stockholder may purchase his pro rata share, as near as can be done without the issuance of fractional shares, on the sale for cash of any previously unissued or new stock of this corporation at the same price at which it is offered to others.
5. REGISTERED AGENT. The initial registered agent for this corporation is LEWIS KIMLER, ESQ. and the initial registered office is located at 600 NE THIRD AVENUE, FORT LAUDERDALE, FL 33304. The Principal address is the same.
