Dear Department of State,


I am writing this letter to address a serious situation on the behalf of my corporation. I have recently discovered a situation that is beyond my control. I have no recourse other than to attempt with full honesty and earnest effort to correct the situation. I am asking for an abatement of traditional penalties and interest in this extreme case. I have been incorporated since 2/12/2001 and have to the best of my ability complied with the Florida and Federal filing requirements.

The Articles of Incorporation for Daingerfield Moving & Storage, Inc. were filed in February of 2001. Unfortunately, the articles were filed with an incorrect address. The correct address at the time was 8739 113th St N. The Articles incorrectly showed the address as 8737 113th St N. The correct address of 8739 is verified on the enclosed Pinellas County property tax record. Further complicating the situation, we moved later in 2001. While we filed the necessary forms to have our mail forwarded to the new address, this only applied to mail sent to the correct old address of 8739. As a result, **WE NEVER RECEIVED the 2002 UBR**. In addition, the 2002 UBR was the first to be filed for the corporation and, therefore, we had no reason to realize we should have received such a form.

Considering the circumstances, we respectfully request the reinstatement of the Corporation and an abatement of all late filing penalties. Enclosed is a Corporation Reinstatement Form, our 2003 UBR, and a check for \$308.75 to cover the 2002 & 2003 filing fees, as well as certificate of status.
