To Whom It May Concern:


I recently received a notice concerning the Uniform Business Report requesting fees of \$550 for failure to file in early 2002. Last week, I had an opportunity to speak with an individual in your offices regarding the matter. Upon her advice, I am writing this letter to request a waiver of \$400 and an extension.

With the exception of the recent failure to file notice, I have not received any official mail from your offices in Tallahassee or Fort Lauderdale. It is my understanding that your computer database system will not accept my address. As I understand it, the U.S. Post Office recently passed down a decision stating that buildings with more than one unit must include a Suite or Studio number. According to the Fort Lauderdale/Broward County office, the state computer system will not accept my address of 1000 NE 43rd Court, Studio E. As a result, mail is addressed to 1000 NE 43rd Court, and the Post Office is not delivering it.

For these reasons, I am requesting the waiver and extension. Please be aware that I have still not received requested materials—i.e. my state tax payment package requested by phone most recently. I include a check for \$150 and hope to hear from you soon regarding this matter.
