

The undersigned incorporators hereby associate themselves together to form a corporation under Chapter 607, Florida Statutes.

ARTICLE I

NAME

The name of the corporation is THE LAW OFFICE OF LEIGH A. TUCKER, P.A. and its principal place of business is 509 South Main Street, Clermont, Florida 34711, with a mailing address of Post Office Box 717, Minneola, Florida 34755.

ARTICLE II

GENERAL PURPOSE

The power to adopt, amend or repeal the Bylaws shall be reserved to the Shareholders of this corporation.


ARTICLE XI
