## ARTICLE VIII

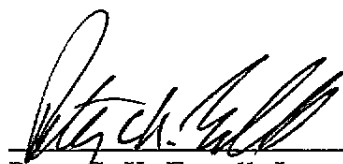

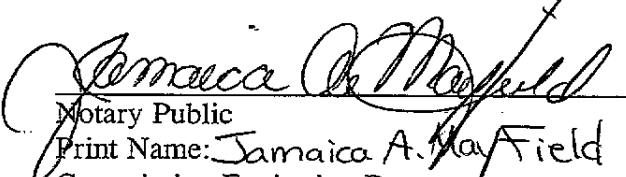
