The undersigned, being all of the stockholders and all of the directors of TUTTI-FRUTTI ENTERPRISES, INC., whose Articles of Incorporation were filed with the Secretary of the State of Florida on February 14, 2001 hereby manifest our intention that the said Articles of Incorporation be amended in accordance with the proposed amendment set forth herein, pursuant to the provisions of Section 607.181 (3), Florida Statutes; and we do hereby request the approval thereof by the Secretary of State; and we do hereby certify that there are no other directors or stockholders in the said TUTTI-FRUTTI ENTERPRISES, INC.

I.

The provisions of Article III of the Articles of Incorporation are hereby deleted in their entirety and the following inserted thereof:

### "Article III Purpose

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act."

II.

The provisions of Article IV of the Articles of Incorporation are hereby deleted in their entirety and the following inserted thereof:

### "Article IV

### Capital Stock

- (a) The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 7500 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in other property (tangible or intangible) or in labor or services actually performed for this corporation, at a fair valuation to be fixed by the Board of Directors. When issued, all shares of stock shall be fully paid and nonassessable.
- (b) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election.
- (c) The voting power of this Corporation shall be vested solely in the Common Stock. Holders of shares of Common Stock, and shall be entitled to one vote for each share of Common Stock. There shall be no cumulative voting in the election of directors.
- (d) Any and all dividends are to be shared among the holders of shares of outstanding Common Stock on a share for share basis.
- (e) The Corporation elects to have preemptive rights in accordance with Section 607.0627 of the Florida Statutes."
