ARTICLES OF INCORPORATION





CENTURY MARKETING GROUP, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation is **Century Marketing Group**, Inc.

The corporation shall exist perpetually unless dissolved according to Florida law.
