### ARTICLE I

#### ARTICLE VIII



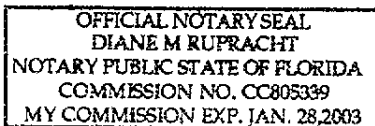

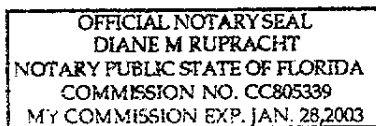
