

ARTICLES OF INCORPORATION * OF

EVERGREENE INSTRUMENTATION AND CONTROLS, INC

ARTICLE I

Name

OTER S M.S. K.S. The name of this corporation shall be EVERGREENE INSTRUMENTATION AND CONTROLS, INC.

ARTICLE II

Nature of Business


