

In compliance with with requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is TBCC ACHIEVEMENT INC.

ARTICLE II

The existence of the corporation shall begin on the date the Articles of Incorporation are filed with the State of Florida.

ARTICLE III




